# 4. Car Show – Chair Fegan

Brendan Giger was in attendance to discuss the car show with committee members. The car show would like to have a series of competitions which would have awards, or plaques handed out. Staff will investigate if a letter to council will be required. Committee members further discussed timeline of the car show. The cars would be on location for 4 hours leaving a gap of a half hour to an hour for the cars to leave and then have the band start at 7pm. Local car clubs are showing high interest. Vehicles will be set up in the back area of Fiddle Park by the community garden on the north side.

Committee members discussed having early registry application for car entries and waiving the fee. On the registration form there can be a requirement to upload their insurance.

Committee members discussed sponsorship opportunities that could help fund the awards or plaques, or gift cards that could be used for an award. Sponsorship would be available if the car donates towards awards, a minimum of \$100.00 sponsorship and the participant can set up a booth.

Committee members agreed on the following wording for the plaques: The Canada Day Festival Committee Recognizes (name/logo), Thanking you for your continued community contributions. Presented, 2022.

# 6. Committee Update

a. Biography for the Town of Shelburne website (175 words maximum)

Staff updated the committee on the biographies that have been received.

b. Social Media Policy – Staff

Staff reviewed the Town of Shelburne Social Media Policy, outlining the policy scope, risks and benefits, conduct and guidelines.

#### **7. General Information** - Discussion Items

#### a. Bands

Committee members discussed the band Settlers Creek outlining the agreement that will be signed by town staff.

#### b. Budget review

Committee members discussed funds from the Street Festival account which have been received. The balance that was transferred to Town was \$9,228.00. The balance is lower than previously provided as there were cheques that were unaccounted for.

#### c. Fireworks

Committee members discussed different types of shows, highlighting shows that range from \$5,000 to \$10,000. Music would be an additional cost and would be more expensive to have the music choreographed with music. With a \$5,000 show the fireworks would last about 5-6 minutes, a \$10,000 show would be about 9-11 minutes.

Committee members agreed on an \$8,000 show for 10 minutes.

#### d. Grant

Committee members discussed the grant in which \$4,000.00 has been received.

#### e. Marketing

Committee members discussed radio ads, free press, social media, LED billboards and flyers. Town staff and committee member Brian McBride have committed to printing. Staff will investigate LED measurements for the LED board at fire hall. Councillor Fegan will create images for advertising. A further discussion ensued regarding costs for renting an A frame or stand-up billboard.

Committee member discussed having a draw for a bike up to \$150 value and having a sponsor for it. A further discussion ensued regarding Go With Crowe handing out Canada flags.

# f. Sponsorships

Committee members discussed having sponsorship opportunities at the event including car sponsors, sponsor for a giveaway bike. Committee members are waiting to hear back from Trainer Games and Ken Bennington. Go With Crowe would like to sponsor Canada Flags and Compass Church will be donating glo sticks.

#### g. Vendors

Committee members discussed not charging car vendors, but the car vendors must be there all day.

A further discussion ensued regarding having Kinsmen run a beer tent. Kinsmen will not be allowed to collect donations at the gate this year. Committee members agreed that all donations should go to the Canada Day event for next year.

Committee members discussed applying for a special occasion permit with the AGCO and that the Kinettes will not be able to work the kitchen.

Staff updated the committee on public health requirements for food vendors during the event. Public health will require all paperwork by June 1, 2022. Currently we have three food vendors Blitzful Treats, The Big H and The Creamery.

#### h. Compass Event

Committee members discussed the Compass event, there are 500 red and 500 white necklaces that have been purchased and donated by Compass.

#### 8. New Business

Committee members discussed creating a large sign to collect donations at the entrance gates.

Committee members discussed the timeline of the event with the car show being from 3:30 pm - 7:30 pm , Band to start at 7:30 pm and the fireworks will start between 10:30 pm and 11:00 pm.

#### a. Band - Settlers Creek

#### c. Car Show

Committee member Brian McBride updated the committee regarding the car show, trillium ford would like to bring two cars with a booth, committee members agreed to charge \$200.00 for two vehicles with one booth.

Committee members discussed activities that will be happening during the car show, Go with Crow will be handing out little Canada flags during the show and Relator Ken Bennington has purchased a bike and helmet for the car show.

Staff updated the committee on requirements for cars and vendors at the show which will require valid insurance and signing of an indemnity form. Committee members discussed creating an online form that both car show participants and vendors can complete.

#### d. Fireworks

Staff updated the committee on the progress of the fireworks display. The invoice was received which amounted to \$9,040.00 with HST. Insurance is still required.

Committee members discussed site plan, fall out zone, start time and effects.

#### e. Marketing

Committee member Kyle Fegan will work on advertisements for the Towns digital signs. Committee member Kyle Fegan will follow up with Lynn Topping for school flyers and update the advertisements with bike draw. Advertising will run in the Shelburne Free Press on the Town page and through the Shelburne Radio Station. Committee member Brian McBride has agreed to print 3,000 flyers and the town will print 500. Committee members discussed creating a banner over top of the road like Streetsville and Alliston.


